2019 Special Legislative Session Omnibus Pension Bill Summary

At the end of the 2019 Legislative Session, the Pension Commission voted on a "draft" pension bill that did not become law. However, the draft pension bill was passed into law in a one-day special session on May 25, 2019. Governor Walz signed the special session pension bill into law on May 30, 2019.

Below are provisions that became law that are of interest to MNFAC:

Military Service Credit Purchases

Members covered by PERA general, police and fire retirement plans may purchase service credit for periods of military leave. Military members will now be able to purchase up to five years of service for military service leave that is not federally protected either because the member did not meet the payment deadlines applicable to leave or because the service occurred prior to public employment. A member requesting to purchase the leave must pay an administrative fee of \$250 for the cost of calculating the purchase price which will be credited toward the purchase. The service credit purchased cannot be used in calculating a disability pension. This provision of the bill, with some modifications, renews a provision that sunset in 2013 with adjustments for administrative costs and new service credit limits.

Increase in Minneapolis Payments to PERA Police & Fire for Relief Associations

This provision establishes the annual amounts to be paid by the City of Minneapolis to the Public Employees Police and Fire Retirement Plan (PERA P&F) on behalf of the Minneapolis Police Relief Association and the Minneapolis Firefighters Relief Association and sets fixed dollar amounts.

PERA Statewide Volunteer Firefighter Plan (PERA SVF)

This provision establishes a process through which a municipality, independent nonprofit firefighting coporation, or a joint powers entity may terminate participation in the PERA SVF. The process includes fully vesting firefighters in their pension benefits, allocating any resources in excess of benefit liabilities and making immediate distributions.

Volunteer Firefighter Relief Association

The part of pension bill includes several provisions recommended by the State Auditor Fire Relief Association Working Group. The substantive changes include reducing the permitted graded vesting schedule from 20 years to 10 years for defined benefit plans, adding provisions regarding the applicable benefit level when a firefighter does not return from a leave or when an inactive firefighter dies or becomes disabled. The provision also allows supplemental benefits to be paid to the designated beneficiaries and estates when there is no surviving spouse or children.

Special Law for City of Austin

The Pension bill extended the 2018 provision that allows the City of Austin to allocate fire state aid between its relief association and contributions to PERA Police & Fire Plan for its full-time firefighters. The provision extends the expiration date indefinitely until the effective date of general legislation that permits the allocation of fire state aid.

Looking ahead to the 2020 Legislative Session

Next year we anticipate significant activity related to the work product of the Fire State Aid Working Group, the Conversions and Dissolutions Working Group, State Auditor's Volunteer Fire Relief Association Working Group and the PERA Statewide Volunteer Firefighter Plan Advisory Board.

Fire State Aid Working Group (PERA)

Staffed by Shana Morse at PERA. Also called the 2% Fire State Aid. The work group was created by 2018 law and completed its work at the end of 2018. None of their work product has been enacted into law.

Nutshell issue: Currently Fire State Aid goes to all cities with volunteer firefighters and must be used for pensions. This group is looking at modifying state law to allow cities to allocate a portion of the fire state aid to pay employer contributions to the PERA Police & Fire Plan. In the 1990's the state permitted the use of FSA for PERA Police & Fire – it was to encourage mergers. Then that use was repealed in 2013. Certain cities were allowed exemptions in 2012.

Staffed by Rose Hennessy-Allen for State Auditor Blaha. Created in 2004 with goal of helping Relief Associations trustees be successful. Meetings convened and chaired by State Auditor. Has representatives from defined benefit plans and defined contribution plans, has both metro and outstate representatives, has two municipal representatives. The Working Group only forwards proposals that receive unanimous consent. This group does not have an end date. Law changes in 2019 bill include changing from 20 to 10 years for defined benefit relief plans, add provision regarding benefits when a firefighter does not return to service or dies and allows supplemental benefits for beneficiaries if there is no spouse. Lots of little items.

Nutshell issue: Much of their agenda was enacted in 2019. Pension Commission asked them to look at vesting schedule issue and augmentation issue in 2019 interim.
